#### Law Enforcement / Criminal intelligence

With over 20 years of experience in the sector, Teched has developed deep expertise in criminal intelligence and policing. We have supported the Croatian Ministry of the Interior's core criminal intelligence operations and helped the Kosovo Police implement Intelligence-Led Policing. Our solutions include integrated case and document management systems, support for criminal investigations, management of surveillance data, secure data exchange, and GIS integration for actionable insights.



#### Public Finance / Revenue Administration

Teched has vast experience in **public finance**, having implemented projects spanning several areas: **budget planning**, **budget simulation**, **budget classification**, **macroeconomic indicators**, and **performance budgeting**. Our IT systems developed in this area include **large data warehouses**, **reporting systems**, and **business intelligence systems** that facilitate the planning, tracking, and management of budget-related financial data. We have significant experience in the area of **revenue administration**, having designed a **Public Revenue Gateway (e-Tax system)** which enables businesses and citizens to electronically submit their tax forms, completely removing the need for paper forms.



#### Health / Social Welfare

Teched has significantly contributed to enhancing health-care quality and accessibility in Croatia. In the **e-Medicines** project, we developed a national platform for the integration and management of medicine-related data. **The Remote Monitoring Services in Emergency Medicine** project further demonstrates Teched's impact, as it contributes to a framework for remote patient monitoring to improve nation-wide access to emergency care. Teched also supported the Croatian Ministry of Health in crafting **the e-Health Strategic Development Plan**, advancing the transformation of digital healthcare. Our CAPI system is compatible with Blaise CAI software and designed for use by interviewers in the field, as well as for survey managers in the central office, and our CAWI system provides a modern approach to on-line data collection.

#### **Justice and Legal Reform**
